## UNAPPROVED MINUTES OF THE REGULAR MEETING OF THE ELK POINT CITY COUNCIL

The Elk Point City Council met in regular session on Monday, March 3, 2014 at 7:00pm in the council chamber of City Hall located at 106 W. Pleasant Street with Mayor Trobaugh presiding and these members present: Verros, McCreary, Fanta, Honomichl and Buum. Absent was: Zevenbergen. Motion made by McCreary, seconded by Fanta to approve the agenda. All in favor.

Honomichl moved and McCreary seconded a motion to approve the minutes from the February 3, 2014 council meeting. Unanimous.

The program allows small communities to apply for a grant to help assist in completing community transportation plans. Motion and second, Buum/McCreary to apply for the Small Community Transportation Planning Grant. All in favor.

Motion made by Verros, seconded by Buum to advertise for a used digger derrick truck as budgeted in the 2014 budget. Unanimous.

McCreary moved and Honomichl seconded a motion to approve a tax abatement request (\$240.45) for the Union County Historical Society on parcel number 03.07.19.1093. All in favor.

Motion and second, McCreary/Fanta to approve a tax abatement request for the Elk Point Economic Development Corporation on Donnelly Tract 5 in the NE ¼ NE ¼ and the SW ¼ NE ¼ less part lying W of I-29, Outlets EP City, Union County South Dakota. All in favor.
